The experimental work was mainly carried out within the research line "Chemistry of Natural Products from Marine Organisms". In recent years, these studies have been increasingly focused on the rationalization of significant biological behavior of benthic invertebrates, in particular, the Opistobranch Mollusks.

He has participated and still participate in many campaigns of underwater sampling benthic organisms in Italy and abroad in international collaborative projects with Spain, Mexico, India, Egypt, China, Azores Islands, Morocco, Senegal. During these campaigns, Dr. Villani has been entrusted with the task of identifying and documenting new benthic microhabitats to highlight the particular mutual relations contracted by these molluscs.

Since 2001 he has collaborated, through underwater pictures and video surveys and visual census of benthic biotic communities, the research program on marine protected areas of Campania under the project "Aphrodite" in collaboration with local research unit CoNISMa (National Interuniversity Consortium for Marine Sciences) at the Department of Zoology, University of Naples Federico II, coordinated by Prof. G.C. Carrada.
